E2a. Long Beach System Upgrade Phase 1 & 2/SP12 & 13/Price Brothers Pipe Replacement/Amendment #6 – Overstreet & Associates

Mr. John Wilson explained that the work for the Long Beach System Upgrade Phase 1 & 2/SP12 & 13/Price Brothers Pipe Replacement/Amendment #6 has been completed. Mr. Wilson requested approval for payment to be made to Overstreet & Associates for the work and explained the matter has been discussed with The City of Long Beach. There were 160 days added to Phase 1 and 301 days added to Phase 2, delays were due to obtaining materials due to the COVID period. Supervisor Marlin Ladner asked Mr. Wilson for the total cost of the engineering services. Mr. Wilson explained that the RPR total is \$717,406.00 and the project total \$7.6 million.

Mr. Bernie Parker made motion to approve Long Beach System Upgrade Phase 1 & 2/SP12 & 13/Price Brothers Pipe Replacement/Amendment #6 – Overstreet & Associates seconded by Mayor Andrew "Fofo" Gilich. A vote resulted in the following:

F. Executive Director's Report

Mr. John Wilson explained that there will be a Public Meeting scheduled for the June 15, 2023, Board Meeting. The Public Meeting will offer the opportunity for public comments or questions regarding expanding two C&D type landfills as part of the Solid Waste Plan. Supervisor Connie Rockco requested clarification, on whether or not, bids could be requested for Harrison County C&D type landfills. Mr. Wilson explained that contracts are locked in with Waste Management. The Board will be updated in the future as progress and updates are available. Mr. Wilson handed out an insurance premium summary listing options for the 2023-2024 period. The prior year insurance premium was \$305,432.00 and the current quote for same coverage amounts are \$619,677.25. There is an option to reduce the property limit coverage from \$10,000,000 to

\$5,000,000 (for a named windstorm) and the premium would be \$426,318.75. Mr. Wilson explained that tanks and pipes usually do not have wind damage. Supervisor Marlin Ladner requested clarification on whether, or not, controls at the plants have been raised. Mr. Wilson explained that controls have been raised due to flooding but the part of policy being discussed is for wind damage. Mayor Billy Hewes noted that due to the nature of the facilities there is minimum wind exposure. Mr. Wilson recommended the "Optional Property Quote" listing a premium of \$426,318.75 and explained that Mr. Greg Cullom, HUB International will present details of property insurance coverage at the June 15, 2023, Board Meeting. A policy should be in place by midnight June 18, 2023.
