E. Financial Report

Ms. Cindy Breaux explained that there are two meetings scheduled for the remaining member agencies' Budget Meetings regarding the FY24 Budget. A final FY24 Budget Draft will be presented at the next Board Meeting.

Supervisor Marlin Ladner requested clarification on some expenditures and line items that were noted as 100%(+) and whether or not items get transferred from one item to another. Supervisor Ladner noted that he had never seen a budget amendment to cover items. Mr. John Wilson explained that a line item maybe 100%, but the facility number may be less, example being chemicals that may result in a surge and then the number will fall back.

Mayor Jimmy Rafferty noted that Mr. Wilson and Ms. Breaux met with Mayor Rafferty at The City of Pass Christian City Hall to explain the FY24 Budget and it was presented well.

No action required. The Board accepted the Financial Report for June 2023 as presented. A copy of the report is attached hereto as exhibit "D".

F. Marketing Report

Ms. Tami Blackwell, The Focus Group, explained that The Focus Group continues to increase traffic to the HCUA website in efforts to increase recycling participation from the public. HCUA's June 2023 recycling participation rate was over the national average, with a participation rate over 42%. Stats include website usage up 70%, with 2,700 new users, page views increased by 64%, click rate increased 286% with an average cost per click of \$.16 per click, with the standard industry average cost per click of \$1.72. Public comments were included in the Marketing Report.

Mr. Al Gombos requested clarification on, whether or not anyone at HCUA has monitored newspaper articles for wastewater topics and whether or not The Focus Group could assist with wastewater topics and topics involving cleaning the environment. Mr. Wilson explained that newspaper articles have not been reviewed but the local news has been monitored for wastewater issues including the local beach and/or notifications from MDEQ.

No action taken. The Board accepted the Marketing Report as submitted by The Focus Group. A copy of the Marketing Report is attached hereto as exhibit "E".

G2e. Waste Pro Assumption of Pelican Contracts, Current and New

Mr. John Wilson explained that Pelican Waste has notified HCUA, that Waste Pro is purchasing Pelican Waste and if there is HCUA Board approval, the purchase will include the current HCUA Solid Waste Contract and the new HCUA Solid Waste Contract (beginning October 2023). The current Solid Waste Contract has two months remaining on a six-year term and the new contract consist of a six-year term with up to ten years with contract extensions. Mr. Wilson added that Mr. Roddie Matherne, CEO with Pelican Waste was in the audience. Mr. Matherne addressed the Board and explained that the decision was made a few months back to sell Pelican Waste and service remaining in the existing contract, for two months, could be completed by Pelican Waste if required.

Supervisor Marlin Ladner questioned Mr. Wilson as to what Mr. Wilson's feelings were regarding the Solid Waste Contract. Mr. Wilson advised he was not inclined to agree to consent of the current contract with only two months left in the contract because there are too many factors to be resolved involving the process.

Mr. James Simpson, Counsel (via teleconference call) explained that the existing contract does contain, in paragraph 27, the option to assign services to another provider with Board approval. Mr. Simpson agreed with Mr. Wilson and explained that with only ten days left to handle a change of a Solid Waste provider, that the process could not be managed in good faith considering the paperwork that would be involved. Mr. Simpson also noted that in the new Solid Waste Contract with Pelican Waste, there are no provisions in the contract with an option to assign or omit the contract, but that does not mean that it's not a possibility. Mr. Simpson also expressed that whether the Board votes "No" or whether the Boards makes no decision at the current Board Meeting, status quo continues. The Board is required to vote on consent to assignment a new Solid Waste contract provider, but a decision is required.

Mr. Gombos requested clarification on whether or not there was protection with a Performance Bond. Mr. Wilson explained that there was a million dollar Performance Bond on the current Solid Waste Contract and a three million dollar Performance Bond on the new Solid Waste Contract.

After Board discussion, the decision was made and agreed by Mr. Roddie Matherne that Pelican Waste would continue and fulfill the current contract and the Board would address the new contract at a future Board Meeting post review of contract by Mr. John Wilson and Mr. James Simpson.

Mr. Al Gombos requested that Mr. John Wilson and Mr. James Simpson, Counsel review Solid Waste Contracts and advise on options to proceed including making a recommendation.
