

F. Marketing Report

Mr. Brett Pund, The Focus Group, presented the Marketing Report for the month of May 2021.

The Face Book stats for May 2021, reached over 54,000 residents, up 99% from April 2021. Engagements were over 1,500. The clicks for ads were over 1,100. The average click rate was 1.24 with an average \$.36 cost per click. The standard industry average is .9 click rate with average cost per click \$1.72.

A solid waste graphics guideline was posted on Face Book in May 2021 and reached over 37,000, and the month of June 2021 has currently over 30,000 engagements.

G2c. Renewal Proposal - Property and Casualty Insurance Renewal

Mr. John Wilson explained that HUB International was the only firm that expressed interest in Proposal for Property and Casualty Insurance. Mr. Wilson introduced Greg Cullom from HUB International.

Mr. Greg Cullom noted rates have increased from last year. The quote of \$282,916 is for all Property and Casualty Insurance Lines of coverage, including Commercial Property, Inland Marine, Equipment Breakdown, General Liability, Business Auto, Cyber Liability, Workers Compensation, and Umbrella Coverages. The quote includes 15% Premium increase for the 06/18/2021 – 06/18/2022 policy period.

Mayor Billy Hewes noted that the coast has built back, after Hurricane Katrina, to a higher standard and higher code guidelines but insurance rates do not seem to reflect the upgrades.

Mr. Michael Leonard, representing the City of Biloxi, arrived and took his seat, with the Board of Directors.

The Change Order also included a change to the scope of services. The award of the project, failed to be in compliance with Procurement guidelines. MDEQ is aware of non-compliance and the request to rescind CO #1 for Long Beach Sewer Upgrade – Project II.

Mr. Jim Simpson noted that the Rescind of Change Order #1 only rescinds the Change Order #1.
