Mayor Andrew "FoFo" Gilich made a motion to discuss the Waste Management Pecan Grove – Expansion Approval & Solid Waste Management Plan Revision - Approval, seconded by Supervisor Marlin Ladner. A vote resulted in the following:

Mayor Billy Hewes asked that Waste Management's representative, Mr. Sam Williams, come forth and answer a few questions he had regarding the impact this may have rates and CPI increases. Mr. Williams confirmed to the Board that this approval would not impact the rates the residents pay today, and that support for this expansion would certainly be taken into consideration when the next renewal comes up. Mayor Hewes, while recognizing that there is a need for this expansion, does worry about how residents will react to continuing rate increases for their solid waste service.

Supervisor Marlin Ladner asked for confirmation that since this proposed expansion would replace space that has been used for debris, and that it would now be used for regular household trash, there are places for debris in the event of another large storm, like Katrina. Mr. Williams explained that yes, there is still room at Fire Tower Road and other landfills, and that in the event of another Katrina level storm much of that related debris would be treated as MSW (municipal solid waste) and be hauled to facilities out of the area anyways, saving Harrison County room in their landfill sites.

Mr. Al Gombos asked if any part of this has anything to do with the ongoing discussion over leachate treatment and disposal from the landfills. Mr. Wilson confirmed that no, it does not, that project is in the works, and we are in discussion, negotiation, and planning stages.
