F. Solid Waste- Recycling Landfill Savings

The Board Members had previously asked how much money and volume was the Authority saving through the recycling program. Mr. John Wilson explained that in general we are keeping around 4,400 tons from going into the landfills and saving around \$74,000.00 a year, meaning we are saving about 10% per year.

Supervisor Dan Cuevas asked about the remaining lifespan of the landfills; Mr. John Wilson explained that that number is dynamic but that there was roughly 30 years remaining.

Supervisor Marlin Ladner brought to Board's attention that following Hurricane Katrina the Harrison County Board of Supervisors had to get emergency permits from the Mississippi Department of Environmental Quality to open multiple dump sites in order to accommodate the influx of storm related debris; which would ultimately have an impact on the remaining lifespans of the landfills in the event of another Katrina type storm. Mr. Alan Lane and Mr. John Wilson both explained to the Board that the two sites that were recently approved, Hurricane Creek and Lamey Bros., were approved with such possibilities in mind and that they would be ready for debris if needed.
