## **G.Executive Director's Report**

Mr. John Wilson reported to the Board that HCUA was beginning to put together the FY2025 Budget.

Mayor Jimmy Raftery asked for an update on the PFAS testing that was done at two of our well sites. Mr. John Wilson reported that Safewater tested two wells, one on the East and one on the West side of the county, and HCUA had also done sampling, using another laboratory, at those same sites; we are awaiting the results. The problem remains that because there are no set standards for what is considered dangerous levels, its hard to know exactly what the results we get back will mean, if they come back showing any PFAS levels at all. Mr. Al Gombos asked how then, if there are no set levels, can articles, and stories like the one the Sun Herald ran serval months ago, claim that there are contaminated water sources in Mississippi. Mr. John Wilson explained to the Board that this was just one of many questions this conversation raises, another being the type of water source being tested: private or public, surface or well, shallow or deep source, etc..

Mr. Al Gombos, and other members of the board agreed that this is about messaging and conveying to the public at large that our water sources are safe and we are doing everything we can to ensure that it stays safe, and we have to make sure that we are ahead of this.

As part of the Executive Director's report Mr. Alan Lane answered some questions and clarified how the House Count for residential collection works. The last one was done in 2022 and we expect the numbers to look bigger due to population growth, but also because this will be a two-unit count. We will be getting an address list from Waste Management for each of the Members to review.
