E2a. Water System – PFAS/PFOS Testing

Mr. Al Gombos made a motion to approve discussion of Water System – PFAS/PFOS Testing, seconded by Mr. Jeremy Harrison. A vote resulted in the following:

Mr. John Wilson reported that HCUA had received the testing results ALS Environmental Lab on the Vidalia Road and Woolmarket Well sites for the presence of PFAS and PFOS chemicals.

The results showed both sites had levels which were just above detection, and far below the Federal Government's proposed limits. HCUA has yet to receive the results from the testing SafeWater Tech did on the same well sites. He reiterated that our wells draw from deep aquifers, not surface sources and that those places that rely on surface sources or shallow depth wells are going to be the ones more at risk for contamination.

Mayor George Bass noted that we now seemed prepared to respond to the public if need be, and Mr. John Wilson concurred that we are watching and aware. Supervisor Marlin Ladner asked about health impacts, to which Mr. John Wilson explained that the studies were on-going but there was nothing conclusive. Supervisor Marlin Ladner offered that we needed to be cautious about raising any unnecessary alarm with the public, and prepared when or if they have questions. Mayor Andrew "FoFo" Gilich stated that we have been proactive as a Board and Agency.

Mr. Jim Simpson went on to discuss what would be needed for him to file a claim in the class action lawsuit, part of which is having a baseline for testing. Mr. John Wilson suggested to the Board that we test the rest of the well sites, an expense of approximately \$500 a well, so that we have a baseline, and then wait for Federal Guidelines.

Supervisor Dan Cuevas asked what the basis for the proposed increases were. Mr. John Wilson explained that they were based off of employee evaluations and the judgement of their supervisors. The overall number of staff has gone from 16 to 15 and the work of that one less person has been absorbed by a couple of others. We are a small office with a small staff and that means that each employee wears several different hats. The Board wanted to be sure that in approving these raises, they would not turn around and several months have to approve the hiring of additional employees in order to ensure the work gets done.
