E2d. FY25 Budget - Preliminary Draft

Mr. John Wilson explained that there were two versions of the draft budget, one version which is straight, one including two additional options, the 1/9th Program that would involve purchasing 1/9th of the number of larger recycling carts each year of the remaining Solid Waste contract until all residents had new, larger recycling carts (35 gal. to 65 gallon). With this plan 1/9th of the residents would receive new carts each year. All residents would be subject to a \$0.61 rate increase per month to help pay for the new carts. The Board questioned if it would ultimately be problematic to have only some of the residents receive the larger recycling carts each year while others have to wait. They also had concerns about the \$0.61 rate increase. Mr. Wilson reminded them that this was only a draft budget and for their consideration.

The second option on the table for consideration is contracting out locates to H2O instead of HCUA employees being responsible for them. Ms. Jaclyn Turner asked about accountability and responsibility in the event that a line is marked incorrectly or not marked entirely and is then damaged by a contractor, that those costs should fall on who ever was responsible for locating the line, not HCUA. Mr. John Wilson explained that would be outlined as part of the arrangement.
