E. Financial Report

Mr. John Wilson explained the budget is on track although certain increases reflect emergency repairs due to Emergency Repairs for Espy Road.

Supervisor Marlin Ladner requested clarification on areas of the Financial Report that listed percentage rates at 100% including explanation of the IT Department percentages.

Mr. Wilson explained areas of increase to Water Department are due to electrical strikes and cost for damages for water repairs. The IT Department budget includes 10 plants, 52 pump stations, garbage, office administration and costs are split and allocated through several areas. They maybe high in one area and offset in another.

Mayor Andrew "Fofo" Gilich requested from Alan Lane to verify that the spelling of names of streets for Waste Management/Pelican Waste records to match the spelling of names of streets with the City of Biloxi records.

The Board accepted the Financial Report for June 2021 as presented. No action required. A copy of the report is attached hereto as exhibit "D".

F. Marketing Report

Mr. Brett Pund, The Focus Group, presented the Marketing Report for the month of June 2021. The focus for the month of June was educating the public on debris guidelines. Ads combined with post reached over 118,000 people on the debris guidelines posted. The quarterly newsletter included the debris guidelines, and a release went out to local media on the debris guidelines. The Focus Group will continue reaching the public with the debris guidelines.

G2a. Distribution List – Solid Waste Guidelines Flyer

Mr. John Wilson explained after review of the distribution cost (\$15,000 - \$20,000) associated with the mailing of debris guidelines to 47,000 residents on garbage routes, a decision was made to contact elected officials and various departments of the member agencies and request assistance with distribution of debris guidelines. Information generated to elected officials will aid in their assistance with complaints from the public regarding debris disposal. Mr. Wilson added that there will also be a process to distribute post storm debris guidelines as member agencies contracts for storm debris disposal.

G2b. Salvage Bar Screen

Mr. John Wilson explained that the Bar Screen is located at the South Gulfport plant and

an engineer with HCDC has requested the bar screen. The bar screen was designed as an add-on, has not been in operation since 1995, and has no value other than scrap value. The salvage process would be tracked through procurement, but an assigned value is required. Mr. Wilson recommends an assigned value of less \$1,000.00 equal to scrap value and transfer the bar screen to Development Commission.

G2c. Water & Sewer Service Policy - Approval

Mr. John Wilson explained, March 2020 there was a Service Jurisdiction Clause in the Water & Sewer Service Policy, at this time, there are no changes being requested regarding the clause.
