## E. Financial Report

Mr. John Wilson noted, HCUA is in the eleventh month of the FY21 financial budget, and the expenses are on target. The water budget is running high and other areas of the FY21 budget are below budget.

No action required. The Board accepted the Financial Report for August 2021 as presented. A copy of the report is attached hereto as exhibit "D".

## F. Marketing Report

Mr. Brett Pund, The Focus Group, reported for the month of August 2021. Posts reached nearly 60,000. Notices posted during the month included a press release regarding Hurricane Ida and information on the perfect ratings HCUA received during The Mississippi State Health Department inspection, on HCUA water systems.

No action taken. The Board accepted the Marketing Report as submitted by the Focus Group. A copy of the Marketing Report is attached hereto as exhibit "E".

### G. Action Items

#### G1. Old Business

### G1a. FY22 Budget w/3% Waste Management CPI

Mr. John Wilson noted, at the last Board Meeting, September 2, 2021, the Board adopted and approved the FY22 Budget that included a 3% increase for Waste Management CPI. The 3% increase for Waste Management would not be in effect until certain conditions and criteria were met by Waste Management. The conditions and criteria would be discussed in the next action item on the current agenda. The final FY22 Budget w/3% Waste Management CPI was handed out at the current Board Meeting. Mr. Wilson noted that this would spread the FY22 Budget on the minutes.

No action taken. A copy of the FY22 Budget w/3% Waste Management CPI is attached hereto as exhibit "F".

#### G1b. Leachate Letter – Pre-Treatment

Mr. John Wilson explained, at the last Board Meeting, September 2, 2021, the CPI 3% increase for Waste Management required a unanimous vote, the vote was not unanimous. A motion was made at the September 2, 2021, Board Meeting, for Waste Management to return with a plan of action including pretreatment plan of leachate, and after a plan was presented, the CPI 3% increase would be considered by the Board.

Mr. Wilson explained that the pretreatment plan before the Board includes pretreatment of leachate at the Pecan Grove Landfill. Leachate would be pumped to the Delisle Plant and once the pretreatment characteristics are determined, any HCUA plant will be able to process leachate without disruption and the process would be a permanent solution. HCUA pretreatment standards have not changed since the initial pre-treatment standards were set by HCUA. Refinement to the plan for pretreatment of leachate would be required from time to time. The next stage is focusing on leachate pretreatment at Pecan Grove Landfill and determine the process required to get acceptable results at minimal costs. Cost estimates will be presented in the next phase of the leachate pretreatment plan.

First motion, Mayor Billy Hewes made motion that the Board authorize a 3% CPI increase with a condition that within a (6) six-month period, Waste Management presents a plan of pretreatment and disposal of leachate, acceptable by Executive Director and the Board. If a pretreatment plan is not presented nor in place, the 3% CPI increase will be rescinded and the Board will not consider another request, for a (2) two-year period, seconded by Mayor Jimmy Rafferty. No vote was taken, and discussion continued.

During continued discussion of leachate pretreatment plan and conditions for the 3% CPI increase, the following re-stated motion was made by Mayor Billy Hewes.

Mayor Billy Hewes made a motion to approve Leachate – Pre-Treatment, under the conditions, Waste Management presents an acceptable plan of treatment and disposal of leachate within (6) six months or the 3% CPI increase would be rescinded, seconded by Mayor Jimmy Rafferty. A vote resulted in the following:

## H. Solid Waste Report

Mr. Alan Lane explained that the reduction in the recycling rate for month of August was due to Hurricane Ida and the increase in yard waste garbage tonnage was also due to Hurricane Ida.

Mr. Al Gombos noted, "for the record", that at the last D'Iberville City Council Meeting, it was noted that the City of D'Iberville was not pleased with services provided by Pelican Waste.

Supervisor Marlin Ladner noted that in the county (Harrison), Pelican Waste is removing piles but not removing the full pile and debris is left scattered on ground.

Mr. John Wilson noted that large debris piles are limited to 8 cubic feet, per address, to be removed during each scheduled route, in order, to service as many residents as possible on each route. Mr. Wilson added HCUA is working on a plan for the removal of debris piled in front of vacant lots.

No action required. The Board accepted the Solid Waste Report as presented. A copy of the Solid Waste Report is attached hereto as exhibit "I".
