F. Action Items

1. Old Business

F1a. Waste Management Disposal - CPI Adjustment FY22

Mr. John Wilson explained that at the last Board Meeting (September 2, 2021), Waste Management Disposal – CPI Adjustment FY22 discussion involved information about the request from Waste Management for a CPI increase of 6.12% per contract, and Mr. Sam Williams with Waste Management modified the request to a 3% CPI increase and Mr. John Wilson recommended a 2% CPI increase.

Mr. John Wilson explained the current rate for Waste Management is \$14.64 a ton plus \$1 per ton to equal \$15.64 a ton. The State of Mississippi gets the \$1 per ton.

Mayor Billy Hewes asked if there would be a request from Waste Management every year for a CPI increase and if leachate could be treated at the landfill.

Mr. Sam Williams noted there would be a request for CPI increase every year. Mr. Williams added that currently leachate is hauled 133 miles one way every day and treatment is possible at the land fill.

Mr. John Wilson explained that in past, an amount of leachate would be delivered to a treatment facility and slowly fed in, even though the quantity was a small amount, the character of the quantity was huge and a factor in the end result and the result was not a positive result in the process. Options now include pretreatment options in land fill and then feed leachate in at a treatment plant. Another option would be at Keegan Bayou Plant. Keegan Bayou Plant has (4) four sbr's but only (3) three are in service. The (4th) fourth sbr could be service and use rehab. Issues involved include figuring out a way to treat fluid and separate sludge, and test flow. Pecan Grove land fill is North of an existing Wastewater Treatment Facility, if leachate is pretreated on site, it can be pumped to Delisle Plant and the Plant could complete the process. H20 has inquired about using a pretreatment package, Silos, but that does involve an upfront cost. If leachate is pretreated in landfill and hauled to plant, as time goes on, leachate will dilute. Mr. Wilson noted that if a treatment plant provides continuous permanent and consistent services, the need for pretreatment standards will be required.

Mr. Sam Williams explained that Waste Management is willing to invest in the pipeline and sewer method to assist the county in managing leachate.

Mayor Billy Hewes requested clarification on the current rate CPI rate to Waste Management.

Mr. John Wilson advised the current rate of the contract will stay in place until the rate is changed. If an adjustment is made to the rate, the new rate would be in effect, October 1, 2021.

Mr. Sam Williams noted, the original contract, begin 2015, and it is a (10) ten year contract, with (5) five year options, total of (30) thirty years.

Mr. Al Gombos noted that all future requests and agreements should be made in writing and any service agreements or contracts that exceed service contract with member agencies, should be reviewed.

Mr. John Wilson explained that Mr. Sam Williams does not want to add any more expense into pretreatment but instead deliver the leachate to the treatment plant.

Mayor Billy Hewes noted that it makes sense to pretreat and pipeline leachate to a plant facility, as a business model decision, but the question, is it required the Board has to make an option available. Mayor Hewes added that there are no commitment documents, and there needs to be a long term solution to address cost factors that have been identified and what is the plan and timeline.

Supervisor Marlin Ladner addressed Mr. Sam Williams and asked if Mr. John Wilson sets standards for pretreating leachate would Waste Management proceed with pretreating.

Mr. Sam Williams replied, "yes".

Mr. Gombos also noted that board has already adopted a sewer use regulation that sets pretreatment standards.

First motion was made by Supervisor Marlin Ladner, Waste Management Disposal – CPI Adjustment FY22, for 2% CPI increase, seconded by Mayor George Bass. No vote was taken. Later during continued discussion of CPI increase and leachate treatment plan, Mayor Andrew "Fofo" Gilich noted that discussion was leading to previous motion of 2% CPI increase motion to a substitute motion of 3% CPI increase.

Mayor Billy Hewes explained to Mr. Sam Williams, if the vote moving forward failed, but a plan of action is presented for pre-treatment on site and piping to Delisle with a timeline, Mayor Hewes committed to change his vote from nay to aye.

Mr. Simpson, Counsel, explained he would need time to review this motion and vote since rate changes require a unanimous vote and he would provide letter on result of vote for CPI increase.

Mr. John Wilson explained that the CPI adjustment in budget currently is for a CPI increase and Budget can be approved as is, continue to pay Waste Management at same rate until Waste Management can supply what is required and then approve at that time for CPI increase.

Mayor Billy Hewes suggested that Board could adopt 3% increase provided Board agrees to plan submitted by Waste Management.

Supervisor Connie Rockco made substitute motion for Waste Management Disposal – CPI Adjustment FY22, from 2% CPI increase to a 3% CPI increase, as long as the plan submitted by

Waste Management, for leachate process and plan, is agreed by Board, seconded by Mayor Jimmy Rafferty. A vote resulted in the following:

F1b. Nicholson Pumps – Award- Documentation for Qualifications

Mr. John Wilson explained that the Nicholson Pumps Award was previously voted on as "Approved" by the Board, as long as, Pickering Firm, Inc. provided further documents regarding specifications of the pumps. Mr. Wilson noted there were two other vendors interested in the bid, but the closest pumps submitted but the other (2) two vendors, did not meet the specifications for the pumps advertised. The pump specifications required a pump with 75 hp and high head condition. Only one vendor bid, the process was followed, submittals received and Pickering provide requested letter (not included in the agenda package but provided at the current Board Meeting), and procurement was followed.

Supervisor Connie Rockco noted to include communication with Harrison County Beautification Department for unincorporated areas.
